I feel this process was tedious, and expressed concern of the assessment of her property. She elaborated on other sales in the Borough and feel the values of the properties went up as high as the listed assessments. She also expressed her displeasure on the new process for Bulk pickup. She feels it is a burden to have to call and request a Bulk pickup.

Mayor Cradle stated the new bulk pickup schedule is in effect to keep house cleanouts from happening. It's costly and contributes to higher tipping fees and footing the bill for landlords. If we have too many

pickups, we add another pickup.
