#### MAYOR'S STATEMENT

Mayor Cradle welcomed all in attendance to the New Year. He further welcomed Wyatt Earp, George Gilmore, Sheriff Mastronardy and Freeholder Haines.

Mayor further stated this Council is one of the best in the County of Ocean. They may not always agree, however he has never doubted how each of them feel about South Toms River. They all care. We are close and will continue to ensure its closure.
