BOROUGH OF SOUTH TOMS RIVER MINUTES OF THE REGULAR MEETING AUGUST 28, 2017, 7:00 PM

Mayor Cradle opened the Meeting of the Borough Council with a Moment of Silence, followed by the Salute to the Flag.

The Municipal Clerk read the following meeting notice:

Mayor Cradle appointed Toni Ellison as a Class IV Member to the Land Use Board, with a term expiring on December 31, 2019. He further thanked her for her response to an motorcycle accident on Dover Road.

PUBLIC HEARING: Big Rod's Results Mercantile License

The Borough Administrator asked for Rod Taylor to step forward.

The Borough Attorney asked Mr. Hailey to raise his right hand and swore him in for the Public Hearing. Mr. McKenna proceeded to do the same for the Code Enforcement Officer, James Richardson.

The Borough Administrator read the infractions found and listed by the Code Enforcement Officer. He asked if anything has changed with these charges relating to the mercantile and/or property..

Mr. Richardson stated that nothing has changed at this time.

Mr. Hailey: I've never sold cars from there. All cars that were asked to be removed have been. All cars are registered and insured with the State of New Jersey. I've never sold a care there.

Borough Administrator: We have a packet with your Facebook advertisements and 11 new photos.

Mr. Ross: Just because you haven't sold a car doesn't mean you aren't selling them there.

Mr. Hailey: I have a lot in Lakewood where my license is issued. If you contact me and I asked you to meet me in South Toms River, that doesn't mean I'm selling them there. The cars need work.

Mr. Ross: Why haven't you mentioned the Lakewood address on Facebook?

Mr. Hailey: I don't have to.

Borough Administrator: Read another advertisement with the advertisement stating the South Toms River address.

Code Officer: I content that he is selling cars at this location.

Mr. Hailey: Can you prove that or is it an allegation?

Mr. Ross: It's up to us to determine that.

Mr. Handshy: Do the cars have For Sale signs on them?

Mr. Hailey: They do not. I've been here since December and you can tell from Facebook that I've never sold a car there.

Mr. Murray: Reading this, it tells me you are selling cars at 65 Flint Road. You shouldn't have this address listed. It says South Toms River and nothing about Lakewood.

Mr. Hailey: That's just the way you are interpreting it. I can't make you understand that I'm not selling cars. These Cars are \$700-\$1,000 and are in need of fixing. The cars here are being worked on. The cars are for sale; no, you can't buy them here, but you can contact me and if you desire to see i, then you can come and look at it. You can purchase it in Lakewood.

Sergeant Kosh: (after being sworn-in by Mr. McKenna): With all due respect to Mr. Hailey, we've had at least three occasions where we've pulled over cars coming from his property, where car are unregistered and all three stated to us that they just purchased the vehicles from Mr. Hailey on Flint Road, and thought they were properly registered. This is what we are being told by people buying the vehicles.

Mr. Hailey: Do you have proof of that?

Sgt. Kosh: They are on bodycam. It will take some research to find it for you.

Mr. Hailey: Then until proven, I don't know how to go about that.

Mr. Handshy: When you repair the cars, why don't you bring them to Lakewood?

Mr. Hailey: I absolutely do.

Mr. Handshy: Then why advertise for South Toms River.

Mr. Hailey: You might assume I'm advertising prior to. At the time I advertise the amount, I may not put the work into ti. The car might not make it back to Lakewood. The car is here, this is where it is. If you would like to examine it, cool. I'll otw it to Lakewood and sign the paperwork there. So they are not being advertised prior to the work.

Mr. Ross: Mr. Richardson, have you seen any cars still unregistered?

Mr. Richardson: I've not seen any cars recently.

The Borough Administrator opened the floor up for any public comments. Seeing none, the public comment portion was closed.

Mr. Hailey: At the beginning, MR. Richardson said nothing changed, however having just stated the cars are now registered, I guess he withdrew his initial statement. The first summons, I got a warning and summons, and within 14 days of that, I got my mercantile revoked. I've noticed ever since I've been noticed, Johnny Muffler and other businesses are not being ticketed and have cars unregistered. Admittedly, at first, I did have cars unregistered. But after that warning, I've gotten rid of these cars and the cars on my property are properly registered. What am I doing that I don't have permission and the other businesses are allowed to have unregistered vehicles?

Borough Administrator: The laws and ordinances are the same for a mercantile license. Other businesses do not have a public hearing for their mercantile license. If you have requested tickets, warnings of other businesses, you would have answers as to who is compliant or not.

Mr. McKenna: What became of the last Court date?

Mr. Hailey: This is it. I plead not guilty and I'm now here.

Borough Administrator: Call the Court Administrator, Monday through Thursday, 5:30pm-8:30pm.

Mr. Ross: Mr. Richardson, has there been anymore complaints from people in town?

Mr. Richardson: I've had complaints. Also, having unregistered vehicles at your establishment is not an illegal business. It's illegal to have them there but it's not an illegal business.

Mr. Cradle: The problem we have is we have a letter stating no cars are being sold at your location on 65 Flin Road, and yet it's being advertised on facebook, and you give the 65 Flint Road address; that is a problem. This is about your mercantile license; not about the summons.

The hearing came to an end with no further comments.

PUBLIC COMMENT

Jason Glogolich, 418 Applegate, expressed his opinion to change the Section 2 pickup to Option B.

Donald Worth, 10 Parkway Blvd, thanked the Council for sending the survey. He stated that he placed the original request a few years ago. He further stated that trash piles high due to the 11 day gap in pickup due to the holiday schedule.

Councilman Rolzhausen thanked Mr. Worth for making this request, and further asked that Mr. Worth stay so he can see the Council decision for the said Section 2 Survey.

Toni Ellison, 3 Easy St, stated that the motorcyclist who sustained injuries in last week's accident is expected to recover.

Councilman Murray motioned to close the Public Comment, Seconded by Councilman Ross, and full Council consent.
